
Mae angen y cyfngiad fel bydd modd cynnal gwaith ar y grisiau i gerddwyr neu'n agos iddyn nhw.

**(TEMPORARY CLOSURE) ORDER 2019**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close the pedestrian steps on both sides leading to the footpath from St Albans Bridge


The restriction is necessary to enable works to be executed on or near the pedestrian steps

The closure is expected to be in operation during the following dates or until such time as the works have been completed

- 24th September 2019 to 25th November 2019
- 6th January 2020 to 1st October 2020

**Alternative pedestrian route** – from the northern side of the closure, proceed via St Albans Road and the footpath to the rear of St Albans Road to the southern end of the closure. From the southern side of the closure, proceed in the opposite direction
