

(TEMPORARY ROAD CLOSURE) ORDER 2019

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close Monk Street from its junction with Jenkin Street to its junction with Griffith Street

The restriction is necessary to enable works to be executed on or near the road in connection with repairs to the water main


The closure is expected to be in operation from 10:30pm on Saturday 16th November 2019 to 6:00pm on Sunday 17th November 2019 or until such time as the works have been completed

Alternative route – from the northern side of the closure, proceed via Wind Street, Ynyslwyd Street and Jenkin Street to the southern side of the closure. From the southern side of the closure, proceed via Catherine Street, Elizabeth Street, Cross Street, Cardiff Street and Victoria Square to the northern side of the closure

Alternative route for larger vehicles – from the south western side of the closure, proceed via A4233 and A4058 to Pontypridd and via A470 and A4059 to Aberdare. For larger vehicles travelling in the opposite direction, reverse the directions given above

Access for emergency service vehicles and pedestrians will be maintained
