Llwybr Amgen – O ochr ddeheuol y ffordd sy'n cael ei chau, ewch ar hyd Y Rhodfa, Heol y Comin a Heol Merthyr i gyrraedd ochr ogleddol y ffordd sy'n cael ei chau

2. Y Lôn Ddienw rhwng 1 Heol Llanof a 101 Heol Merthyr

Llwybr Amgen – O ochr ddeheuol y ffordd sy'n cael ei chau, ewch ar hyd Heol Merthyr, Heol Scarborough a Pleasant View i gyrraedd ochr ogleddol y ffordd sy'n cael ei chau


I gerbydau sy'n teithio i'r ffordd arall, dilynwch y drefn uchod am yn ôl

(TEMPORARY ROAD CLOSURE) ORDER 2019

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close the following sections of roads: -

1. Holly Lane, from its junction with Merthyr Road, south east for 26 metres

Alternative Route – from the southern side of the closure, proceed via The Avenue, Common Road and Merthyr Road to the northern side of the closure

2. The Unnamed Lane between 1 Llanover Road and 101 Merthyr Road

Alternative Route – from the southern side of the closure, proceed via Merthyr Road, Scarborough Road and Pleasant View to the northern side of the closure


For vehicles travelling in the opposite direction, reverse the directions given above

The restriction is necessary to enable works to be executed on or near the road in connection with footway resurfacing works along A4054 Merthyr Road

The closure is expected to be in operation on 6th January 2020 to 17th February 2020 or until such time as the works have been completed

Access for pedestrians and emergency service vehicles will be maintained
