Bydd y ffordd ar gau o 6 Ionawr 2020 am 11 mis yn olynol neu hyd nes bydd y gwaith wedi'i gwblhau.


**Llwybr Arall**

**(TEMPORARY CLOSURE) ORDER 2019**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close the following:-

1. St Albans Bridge, Tynewydd for its full extent
2. The public path between Penpoch Community Primary School and Blaen-Y-cwm Road, Tynewydd

The restriction is necessary to enable works to be executed on or near the road in connection with the replacement of the bridge deck

The closure is expected to be in operation on 6th January 2020 for a period of 11 months consecutively, or until such time as the works have been completed


**Alternative route**

1. From the eastern side of the closure proceed via St Alban's Road, Blaen-Y-Cwm Road and Blaenrhondda Road
2. From the northern side of the closure proceed via the unnamed public path, Blaenrhondda Road and Blaen-Y-Cwm Road

For vehicles travelling in the opposite direction, reverse the directions given above

Access will **NOT** be maintained for pedestrians or emergency service vehicles
