2. Y ffordd fynediad o flaen Llys Brynderwen



**(TEMPORARY ROAD CLOSURE) ORDER 2019**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close the following sections of roads:-

1. The lane to the rear of Church Street, from its junction with North Road, eastwards for a distance of 36 metres
2. The access road fronting Brynderwen Court


The restriction is necessary to enable works to be executed on or near the road in connection with the installation of a new water main

The closure is expected to be in operation from 6th January 2020 to 16th January 2020 or until such time as the works have been completed

Access will **NOT** be maintained for emergency service vehicles

Access will be maintained for pedestrians and for residents' vehicles
