
Cynigir mesurau tebyg i gael ei gyflwyno ar yr A473 ar ddatblygiad Tŷ arloesi

PROPOSED NO WAITING AT ANY TIME A473, Ffordd Y Gwaith Glo, LLANHARAN

The new residential and commercial development constructed at Ffordd Y Gwaith Glo, Llanharan has generated increased number of vehicle movements in the area with the commercial properties attracting a number of visitors.

Despite the provision of off street parking, increasing numbers of visitors to both the residential and commercial development are parking on the entrance road to Ffordd Y Gwaith Glo and the A473 which is impacting the free flow of traffic and presenting a danger to other road users.

Similar measures are proposed to be introduced on the A473 at the Innovation House development

To address these concerns, proposals are currently being developed to introduce waiting restrictions on the A473 and Ffordd Y Gwaith Glo. Details of the proposals are shown on the attached drawing T2019/37/1 and can also be viewed at www.rctcbc.gov.uk/traffic.

The next stage in the process is a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any concerns they may have. If you wish to object to the proposals, you should do so in writing by 5 September 2019 to the Traffic Manager, Traffic Management, Sardis House, Sardis Road, Pontypridd, CF37 1DU or alternatively by email at trafficservices@rctcbc.gov.uk
