Welsh Government funding has been secured to introduce a Safe Routes in the Community (SRIC) scheme in the Llwynypia area.

The proposed scheme, which is currently being developed, will introduce a 20mph speed limit, waiting restrictions and crossing facilities in various roads in the Llwynypia area.
