Mae angen y cyfyngiad fel bydd modd cynnal y gwaith ar y ffordd neu yn ei hymyl o ganlyniad i osod prif biben ddŵr newydd.

Mae disgwyl i'r Gorchymyn fod mewn grym rhwng 3 a 5 Chwefror 2020, neu hyd nes i'r gwaith gael ei orffen.


**Llwybr arall**

**(TEMPORARY CLOSURE) ORDER 2020**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close Volunteer Street, from its junction with Carne Street, south westwards for a distance of 10 metres

The restriction is necessary to enable works to be executed on or near the road in order to install a new water connection

The closure is expected to be in operation from 3rd – 5th February 2020, or until such time as the works have been completed


**Alternative route**

From the southern side of the closure, proceed via Albert Street, Windsor Street and Carne Street to the northern side of the closure

For vehicles travelling in the opposite direction, reverse the directions given above

Access will be maintained for pedestrians but **NOT** for emergency service vehicles
