GORCHYMYN (CAU DROS DRO) 2020

DYMA HYSBYSIAD bod Cyngor Bwrdeistref Sirol Rhondda Cynon Taf yn bwriadu gwneud Gorchymyn, ar ôl o leiaf 7 diwrnod o ddyddiad yr Hysbysiad yma, o dan Adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, fel y'i diwygiwyd gan Ddeddf Traffig Ffyrdd (Cyfyngiadau Dros Dro) 1991, a fydd yn para deunaw mis ar y mwyaf.

Effaith y Gorchymyn fydd cau'r rhannau canlynol o ffyrdd a throedffyrdd dros dro:

1. Stryd yr Eglwys Uchaf, Pontypridd i gyd
2. Ffordd y Rhondda (A4058), Stryd y Felin (A4058) a Stryd Catrin (A4223), lonydd Pontypridd tua'r gogledd o'r gyffordd â Ffordd Graigwen am bellter o oddeutu 230 metr
3. Pob troedffordd o flaen adeilad Tŷ Pennant a Maes Parcio Stryd Catrin

Mae angen y cyfyngiad fel bydd modd cynnal gwaith ar y ffordd neu yn ei hymyl mewn cysylltiad â gwaith glanhau ffenestri Tŷ Pennant.

Mae disgwyl i'r Gorchymyn fod mewn grym o 5.00am tan 12.00pm ar 22 Mawrth 2020, neu hyd nes y bydd y gwaith wedi'i gwblhau.


Llwybr Amgen - Cau Ffordd 2

O ochr dde-orllewinol y ffordd sydd ar gau, ewch ar hyd Heol Sardis (A4058), Broadway (A4058), y slipffordd tua'r gogledd, Cyfnewidfa Stryd y Bont, Stryd y Bont (A4223), Heol Gelliwastad (A4223) a Stryd Catrin (A4223) at ochr ogleddol y ffordd sydd ar gau.

**(CATHERINE STREET AND UPPER CHURCH
STREET, PONTYPRIDD)**

(TEMPORARY CLOSURE) ORDER 2020

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close the following sections of roads and footways:

1. Upper Church Street, Pontypridd for its entire length
2. Rhondda Road (A4058), Mill Street (A4058) and Catherine Street (A4223), Pontypridd northbound lanes from the junction with Graigwen Road for a distance of approximately 230 metres
3. All footways fronting the 'Ty Pennant' building and Catherine Street Car Park

The restriction is necessary to enable works to be executed on or near the road in connection with window cleaning of 'Ty Pennant'

The closure is expected to be in operation from 5:00am to 12:00pm on 22nd March 2020 or until such time as the works have been completed.


Alternative Route - Closure 2

From the south western side of the closure, proceed via Sardis Road (A4058), Broadway (A4058), northbound slip off, Bridge Street Interchange, Bridge Street (A4223), Gelliwastad Road (A4223) and Catherine Street (A4223) to the northern side of the closure.

NB – There will be a temporary suspension of the 'Bus Only Lane' on Catherine Street (A4223) to accommodate other motor vehicles whilst work is ongoing.

Access will be maintained for pedestrians and emergency service vehicles
