1. **Stryd Canon, o'i chyffordd â'r Stryd Fawr i'w chyffordd â Stryd Caerdydd/Sgwâr Fictoria**
2. **Y Stryd Fawr, y lôn tua'r de, o'i chyffwrdd â Stryd Seymour i'w chyffwrdd â Stryd Canon**

Mae angen y cyfyngiad fel bydd modd cynnal gwaith sy'n gysylltiedig a safle'r craen ar y ffordd neu yn ei hymyl.



Bydd llwybr amgen ar gyfer cerbydau: wrth deithio o ochr ogleddol y ffordd sy'n cael ei chau, ewch tuag at Gylchfan y Gadlys, A4233, A4059 Ffordd Osgoi Aberdâr, Cylchfan Tinney's a Stryd Caerdydd tuag at ochr ddeheuol y rhan o'r ffordd sydd wedi'i chau.

(TEMPORARY CLOSURE) ORDER 2020

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close the following lengths of roads:

1. **Canon Street, from its junction with High Street, to its junction with Cardiff Street / Victoria Square**
2. **High Street, southbound lane, from its junction with Seymour Street to its junction with Canon Street**

The restriction is necessary to enable works to be executed on or near the road in connection with the siting of a crane.


The closure is expected to be in operation from 6:00am to 4:00pm on Sunday 29th March 2020 or until such time as the works have been completed.

The alternative route for vehicles shall be from the northern side of the closure proceed via Gadlys Roundabout, A4233, A4059 Aberdare Bypass, Tinneys Roundabout and Cardiff Street to the southern side of the closure.

For vehicles traveling in the opposite direction reverse the directions given above.

Access will be maintained for pedestrians and emergency service vehicles
