DYMA HYSBYSIAD bod Cyngor Bwrdeistref Sirol Rhondda Cynon Taf yn bwriadu gwneud Gorchymyn, ar ôl o leiaf 7 diwrnod o ddyddiad yr Hysbysiad yma, o dan Adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, fel y'i diwygiwyd gan Ddeddf Traffig Ffyrdd (Cyfyngiadau Dros Dro) 1991, a fydd yn para deunaw mis ar y mwyaf. Mae'r cyfyngiadau'n hanfodol er mwyn galluogi cyflawni gwaith ar y ffordd neu'n agos ati mewn cysylltiad â gwaith i adeilad YMCA, fydd yn cynnwys codi â chraen.

Effaith y Gorchymyn fydd:-

1. Cau ffordd dros dro

Stryd Morgan o'i chyffordd â Stryd Crossbrook, i gyfeiriad y gogledd-ddwyrain am 90 metr

Llwybr arall - o ochr ddeheuol y ffordd sydd ar gau, ewch ar hyd Heol Gelliwastad, Stryd Catrin, Heol Sardis (A4058), Broadway (A4058), ewch ar y slipffordd tua'r gogledd, at Gyfnwidfa Stryd y Bont a Stryd y Bont i gyrraedd ochr ogleddol y rhan o'r ffordd sydd ar gau.

O ochr ogleddol y ffordd sydd ar gau, ewch ar hyd Stryd y Bont, Cyfnwidfa Stryd y Bont, ar slipffordd yr A470 tua'r de, ar hyd Ffordd Gyswilt ar draws y Cwm yr A470, Broadway, system gylchu Heol Sardis, Stryd y Felin, Stryd Catrin a chyrraedd ochr ddeheuol y rhan o'r ffordd sydd wedi cau.

Bydd Heol Gelliwastad ar gyfer mynediad yn unig tra bydd y ffordd ar gau.

Nodwch: Bydd 'Gorchymyn (Stryd Morgan, Pontypridd) (Gwahardd Troi i'r Dde) 2012 Cyngor Bwrdeistref Sirol Rhondda Cynon Taf' yn cael ei atal ei atal yn ystod y cyfnod y bydd y ffordd ar gau er mwyn caniatáu i gerbydau sy'n teithio i gyfeiriad y gogledd-ddwyrain gael mynediad ar hyd Stryd Morgan a throi i'r dde i Stryd Taf.

2. Cyfyngiad Pwysau (Dros 7.5 tonnelli) Dros Dro

Stryd Crossbrook, o'i chyffordd â Stryd Taf i'w chyffordd â Stryd Morgan

Llwybr Arall ar gyfer cerbydau dros 7.5 tonnelli - o ochr dde-ddwyrain ardal y gwaharddiad, ewch ymlaen ar hyd Stryd Taf, Stryd Fawr, Heol Sardis (A4058), Broadway (A4058), ar y slipffordd tua'r gogledd, dros Gyfnwidfa Stryd y Bont, ar hyd Stryd y Bont a Stryd Morgan a chyrraedd ochr ogledd-orllewinol y gwaharddiad.

Yn ystod cyfnod y gorchymyn, bydd cerbydau sy'n drymach na'r cyfyngder pwysau dros dro yn cael eu harwain trwy Stryd Taf a'r Stryd Fawr.

Mae disgwyl i'r Gorchymyn fod mewn grym rhwng 16 Mawrth a 25 Hydref 2020, neu hyd nes i'r gwaith gael ei orffen.

Bydd mynediad i gerbydau'r gwasanaethau brys a cherddwyr yn parhau.

RHONDDA CYNON TAFF COUNTY BOROUGH COUNCIL

(TEMPORARY CLOSURE AND WEIGHT LIMIT
RESTRICTIONS) ORDER 2020

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months. The restrictions are necessary to enable works to be executed on or near the road in connection with construction work to the YMCA building including crane lifts.

The effect of the Order will be to:-

1. Temporary Road Closure

Morgan Street, from its junction with Crossbrook Street, north eastwards for a distance of 90 metres

Alternative Route – from the southern side of the closure, proceed via Gelliwastad Road, Catherine Street, Sardis Road (A4058), Broadway (A4058), northbound slip off, Bridge Street Interchange and Bridge Street to the northern side of the closure.

From the northern side of the closure, proceed via Bridge Street, Bridge Street Interchange, A470 Southbound Slip Road, A470 Cross Valley Link Road, Broadway, Sardis Road, Sardis Road Gyratory, Mill Street, Catherine Street to the southern side of the closure.

For the duration of the closure, Gelliwastad Road will be for access only

NB. The 'Rhondda Cynon Taff County Borough Council (Morgan Street, Pontypridd) (Prohibition of Right Turn) Order 2012' will be temporarily suspended for the duration of the closure to allow all vehicles to proceed in a north easterly direction along Morgan Street and make a right turn into Taff Street.

The closure is expected to be in operation during the following dates and times, or until such time as the works have been completed.

- 6:00am on 20th June 2020 to 11:00pm on 21st June 2020
- 6:00am on 31st October 2020 to 11:00pm on 1st November 2020

2. Temporary 7.5 Tonne Maximum Gross Weight Limit

Crossbrook Street, from its junction with Taff Street to its junction with Morgan Street

Alternative Route for vehicles over 7.5 tonne limit – from the south eastern side of the prohibition, proceed via Taff Street, High Street, Sardis Road (A4058), Broadway (A4058), northbound slip off, Bridge Street Interchange, Bridge Street and Morgan Street to the north western side of the prohibition

For the duration of the order, vehicles exceeding the temporary weight limit will be chaperoned through Taff Street and High Street

The prohibition is expected to be in operation from 16th March – 25th October 2020 or until such time as the works have been completed.

Access for emergency services and pedestrians will be maintained.
