DYMA HYSBYSIAD bod Cyngor Bwrdeistref Sirol Rhondda Cynon Taf yn bwriadu gwneud Gorchymynion amrywiol o dan Adranau 1, 2 a 4 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984 ("y Ddeddf"), ar ôl ymgynghori â Phrif Swyddog yr Heddlu yn unol ag Adran 23(2)(a) o'r Ddeddf honno, ac wedi hysbysu Llywodraeth Cymru mewn ysgrifen, a phob pŵer galluogi arall, a'i effaith fydd:

1. Amrywio'r Gorchymyn Rheoleiddio Traffig wedi'i nodi yn Atodlen 1
2. Cyflwyno cyfyngiadau aros ar hyd y ffyrdd wedi'u nodi yn Atodlen 2
3. Sefydlu Croesfan Pâl i Gerddwyr yn y lleoliadau sydd wedi'u nodi yn Atodlen 3

Rhaid anfon gwrthwynebiadau i'r cynnig mewn ysgrifen, gyda'r rhesymau dros eu gwneud, at y Rheolwr Traffig, Tŷ Sardis, Heol Sardis, Pontypridd CF37 1DU, erbyn 10 ebrill 2020.

ATODLEN 1 – Amrywiad

1. Bydd "Gorchymyn Cydgrynhoi (Gwahardd a Chyfyngu ar Aros a Llwytho ac ar Lefydd Parcio Stryd) 2012 Cyngor Bwrdeistref Sirol Rhondda Cynon Taf" yn cael ei amrywio fel bod y Gorchymyn y cyfeiriwyd ato yn yr Atodlen Gorchymynion fel "Gorchymyn Cyfyngu ar Aros Cyngor Sir Morgannwg Ganol (Cwmdare Road, Aberdâr) 1995". Bydd yn cael ei amrywio fel a ganlyn:
 - a. Bydd Atodlen 2 - Ochr y gogledd-orllewin (eitem ii) nawr yn dweud:

'O bwynt 130 metr i'r gogledd-ddwyrain o ochr ogledd-ddwyrain ei chyffordd â Graiglwyd, i'r gogledd-ddwyrain am bellter o 63 metr'


ATODLEN 2 – Gwahardd Aros ar Unrhyw Adeg

1. **Ffordd y Fynwent**
 - a. Ochr ogledd-ddwyrain, o'i chyffordd ddeheuol gyda'r fynedfa i Station Place, i gyfeiriad de-ddwyrain am bellter o 94 metr
 - b. Ochr dde-orllewinol, o'i chyffordd ag ochr ogledd-orllewinol Heol Cwmdâr, at gyfeiriad y gogledd-orllewin am bellter o 18 metr
 - c. Yr ochr ddeheuol, o'i chyffordd de-ddwyrainol â Heol Cwmdâr, i gyfeiriad y gogledd-ddwyrain am bellter o 46 metr
2. **Heol Cwmdâr**
 - a. Ochr ogledd-orllewinol o bwynt 223 metr i'r gogledd-ddwyrain o ochr ogledd-ddwyrainol ei chyffordd â Graiglwyd, i'r gogledd-ddwyrain am bellter o 12 metr

AND PEDESTRIAN CROSSING NOTICE 2020

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make various Orders under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act"), after consultation with the Chief Officer of Police in accordance with Section 23(2)(a) of the said Act and having notified the Welsh Government in writing, proposes the following and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Order specified in Schedule 1
2. Introduce Waiting Restrictions on the lengths of roads specified in Schedule 2
3. Establish Puffin Pedestrian Crossings at the location specified in Schedule 3

A copy of the relevant documents may be inspected during normal office hours at the Principal Offices of the Rhondda Cynon Taff County Borough Council, The Pavilions, Cambrian Park, Clydach Vale, Tonypany, CF40 2XX and Aberdare Library, Green Street, Aberdare, CF44 7AG until 10 April 2020

Objections to the proposal together with the grounds on which they are made must be sent in writing to the Traffic Manager, Sardis House, Sardis Road, Pontypridd, CF37 1DU by 10 April 2020

SCHEDULE 1 – Variation

1. The "Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2012" shall be varied in that the order referred to in the Schedule of Orders as 'Mid Glamorgan County Council (Cwmdare Road, Cwmdare, Aberdare) (Revocation and Prohibition of Waiting) Order 1995' shall be varied as follows:
 - a. Schedule 2 - North western side (item ii) shall now read:

'From a point 130 metres, north east of the north eastern side of its junction with Graiglwyd, north eastwards for a distance of 63 metres'


SCHEDULE 2 - Prohibition of Waiting At Any Time

1. **Cemetery Road**
 - a. North eastern side, from its southern junction with the access to Station Place, in a south easterly direction for a distance of 94 metres
 - b. South western side, from its junction with the north western side of Cwmdare Road, in a north westerly direction for a distance of 18 metres
 - c. Southern side, from its south eastern junction with Cwmdare Road, in a north easterly direction for a distance of 46 metres
2. **Cwmdare Road**
 - a. North western side from a point 223 metres, north east of the north eastern side of its junction with Graiglwyd, north eastwards for a distance of 12 metres

SCHEDULE 3 – Puffin Pedestrian Crossing

Establish a signalled controlled Puffin Crossing on Cwmdare Road, Aberdare, 24 metres south west of its junction with Cemetery Road
