**1. Stryd Edward, ochr dde-ddwyreiniol**

- a. Ar ochr dde-ddwyreiniol Stryd Edward o bwynt sydd 5 metr tua'r de-orllewin o'i chyffordd â Heol y Gogledd tua'r de-orllewin i ffin gyffredin rhifau 1 a 2, am bellter o 10 metr
- b. O ffin gyffredin rhifau 2 a 3, tua'r de-orllewin am bellter o 10 metr
- c. O bwynt sydd 5 metr tua'r gogledd-ddwyrain o'r gyffordd ag Stryd y Seiffon, tua'r gogledd-ddwyrain am bellter o 24 metr.

- b. O bwynt sydd 5 metr tua'r gogledd-ddwyrain o'r gyffordd â Stryd Y Seiffon, am bellter o 24 metr tua'r gogledd-ddwyrain.

1. Introduce Residents Parking on the lengths of roads specified in Schedule 1
2. Introduce Limited Waiting for 2 hours with no return within 4 hours Monday to Saturday 8am-6pm

**SCHEDULE – Shared Residents Parking and Limited Waiting 2 hours no return within 4 hours Monday to Saturday 8am – 6pm**

**1. Edward Street, south eastern side**

- a. The south eastern side of Edward Street from a point 5 metres south west of its junction with North Road south westwards to the common boundary of No. 1 and 2, a distance of 10 metres
- b. From the common boundary of No. 2 and 3, south westwards for a distance of 10 metres
- c. From a point 5 metres north east of its junction with Syphon Street north eastwards for a distance of 24 metres

**2. Edward Street, north western side**

- a. The north western side of Edward Street from a point 5 metres south west of its junction with North Road south westwards for a distance of 25 metres
- b. From a point 5 metres north east of its junction with Syphon Street north eastwards for a distance of 24 metres
