

1. Bydd "Deddf Rheoleiddio Traffig Cyngor Sir Morgannwg Ganol 1967, Adran 21 – Croesfan i Gerddwyr, Bwrdeistref Cwm Cynon (Dosbarth 3) " yn cael ei amrywio trwy ddileu 'eitem 3/Z20' yn ei chyfanrwydd o Atodlen (b) Croesfannau Sebra
2. Bydd croesfan pâl wedi'i rheoli â signalau yn cael ei gosod ar New Road (A4059) Aberpennar 45 metr i'r gogledd-orllewin o'i chyffordd ag Upper Forest Level

(PEDESTRIAN CROSSING) NOTICE 2020


NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council in exercise of their powers under Section 23 of the Road Traffic Regulation Act 1984 and after consultation with the Chief Officer of Police in accordance with Section 23(2)(a) of the said Act and having notified the Welsh Government in writing, proposes the following: -

1. The "Mid Glamorgan County Council Traffic Regulation Act 1967, Section 21 – Pedestrian Crossings, Borough of Cynon Valley (District 3)" shall be varied by the removal of 'item 3/Z20' in its entirety from Schedule (b) Zebra Crossings
2. Establish a signalled controlled puffin crossing on New Road (A4059) Mountain Ash 45 metres north west of its junction with Upper Forest Level
