

(REVOCAION, VARIATION, WAITING RESTRICTIONS AND SPEED LIMIT) ORDER 2021

AND PEDESTRIAN CROSSING NOTICE 2020

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2, 4, 81, 82, 83 and 84 of the Road Traffic Regulation Act 1984 (“the Act”), after consultation with the Chief Officer of Police in accordance with Section 23(2)(a) of the said Act and having notified the Welsh Government in writing, proposes the following and of all other enabling powers, the effect of which will be to:

1. Revoke the Traffic Regulation Order specified in Schedule 1
2. Vary the Traffic Regulation Orders specified in Schedule 2
3. Introduce Waiting Restrictions on the lengths of roads specified in Schedule 3
4. Establish a Zebra Pedestrian Crossing at the location specified in Schedule 4
5. Introduce a 30mph Speed Limit on the lengths of road specified in Schedule 5
6. Introduce a 20mph Speed Limit on the lengths of road specified in Schedule 6

SCHEDULE 1 – Revocation

1. The “Mid Glamorgan County Council (Cilfynydd Road, (Route A4054) Cilfynydd) (Restricted Roads) Order 1988” shall be revoked in its entirety

SCHEDULE 2 – Variation

1. The ‘Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) (Consolidation) Order 2012’ shall be varied in that the order referred to in the Schedule of Orders as “Mid Glamorgan County Council (Bedw Road, Cilfynydd) (Prohibition of Waiting) Order 1989” shall be varied in that item ‘ii’ shall be removed in its entirety.
2. The “Mid Glamorgan County Council Road Traffic Regulation Act 1967 Section 21 – Pedestrian Crossings” shall be varied by the deletion of the following items from Borough of Taff-Ely (District 6) Zebra Crossing:
 - ii. 6/27 Cilfynydd – Cilfynydd Road outside Richard Arms

SCHEDULE 3 – Prohibition of Waiting At Any Time

1. **Cilfynydd Road, Cilfynydd**
 - a. The eastern side, from the southern side of its junction with Bedw Road to a point 3 metres north of the common boundary of No. 99/98 Cilfynydd Road
2. **Bedw Road, Cilfynydd**
 - a. The south eastern side, from its junction with Cilfynydd Road in a north easterly direction to the common boundary of No. 27 and 28 (Bryn Bedw)

SCHEDULE 4 – Zebra Pedestrian Crossing

1. Establish a Zebra type pedestrian crossing on Cilfynydd Road, Cilfynydd (A4054) 16 metres north of the northern boundary of No. 4 Cilfynydd Road

SCHEDULE 5 – 30mph Speed Limit


