

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Orders as specified in Schedule 1
2. Introduce waiting restrictions as described in Schedule 1

Schedule 1 – Variations

1. The “Rhondda Cynon Taff County Borough Council Prohibition and Restriction of Waiting and Loading and On Street Parking Places Consolidation Order 2012” shall be varied by the deletion in their entirety of the orders referred to in the Schedule Of Orders as:
 - a. The Urban District of Mountain Ash (Various Streets, Prohibition and Restriction of Waiting) Order 1973
 - b. Mid Glamorgan County Council (Rheola Street (B4275) and Unnamed Road connecting to Glanlay Street Penrhiwceiber) (Prohibition of Waiting) Order 1982
 - c. Mid Glamorgan County Council (Cross Lake Street, Lake Street and Frederick Street Ferndale) (Revocation and Prohibition of Waiting) Order 1975
 - d. The Rhondda Borough Council (Unnamed Road off Trellaw Road Trellaw) (Prohibition of Waiting) Order 1971
 - e. Mid Glamorgan County Council (Blaenlau Street Penygraig) (Prohibition of Waiting) Order 1985
 - f. Mid Glamorgan County Council (Brithweunydd Road (Route A4058) and Brynteg Terrace Trellaw) (Prohibition of Waiting) Order 1985
 - g. Mid Glamorgan County Council (Lewis Street and Associated Lane off Lewis Street Pentre, Rhondda) (Prohibition of Waiting) Order 1987
 - h. Mid Glamorgan County Council (Ynyscynon Road (Route A.4058) and Unnamed Road Trellaw) (Prohibition of Waiting) Order 1989
 - i. Mid Glamorgan County Council (Brook Street Williamstown) (Prohibition of Waiting) Order 1993
2. The “Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2012” shall be varied so that orders referred to below which appear in the Schedule of Orders shall be varied as follows:
 - a. “Rhondda Borough Council (Gethin Road James Terrace and Pleasant Road Penygraig) (Prohibition of Waiting Order) 1973” shall be varied by the deletion of the second schedule in its entirety
 - b. “Mid Glamorgan County Council (Scott Street Margaret Street Gwendoline Street and Mountain View Treherbert) (Prohibition of Waiting) Order 1977” shall be varied by the removal of schedule II relating to the north western side of Margaret Street Treherbert
 - c. “Mid Glamorgan County Council (Various Streets Treorchy) (Prohibition of Waiting) Order 1980” shall be varied by the removal of item 2 from schedule II relating to the north eastern side of Regent Street Treorchy
 - d. “Mid Glamorgan County Council (Unnamed Road between Partridge Road and Church Street Llwynypia) (Prohibition of Waiting) Order 1995” shall be varied by the deletion of item (1) of the schedule
 - e. “Rhondda Cynon Taff County Borough Council (Cowbridge Road Talbot Green) (Revocation Prohibition of Waiting At Any Time No Stopping on School Keep Clear Markings and 20 MPH Speed Limit) Order 2006” shall be varied by the deletion from Part 2 Prohibition of Waiting At Any Time (a) Cowbridge Road Talbot Green of item ii)

Schedule 2 – Prohibition of Waiting At Any Time

1. Rhondda

- a. The western side of Ynyscynon Road Trellaw from the common boundary of Nos 202 and 203 northwards to the common boundary of Nos 204 and 205 a distance of 22 metres

- b. Both sides of the Unnamed Road located between No.s 203 and 204 Ynyscynon Road Trellaw from its junction with Ynyscynon Road westwards for a distance of 5 metres
- c. Both sides of Lewis Street Pentre from its junction with Treharne Street south eastwards for a distance of 5 metres
- d. The north side of Lewis Street Pentre from a point 18 metres south east of its junction with Treharne Street south eastwards for a distance of 5 metres
- e. Both sides of Lewis Street Pentre from the lane adjacent to No.s 28 and 29 north westwards for a distance of 5 metres
- f. Both sides of the lane adjacent to No.s 28 and 29 Lewis Street Pentre for a distance of 60 metres
- g. The north western side of Blaenlau Street Penygraig from its junction with Hendrecraf Road south westwards for a distance of 30 metres
- h. The south eastern side of Blaenlau Street Penygraig from its junction with Hendrecraf Road south westwards for a distance of 10 metres
- i. The south western side of Brithweunydd Road Trellaw from the common boundary of No.s 211 and 212 north westwards to the common boundary of No.s 213 and 214 a distance of 22 metres
- j. Both sides of Brynteg Terrace Trellaw from its junction with Brithweunydd Road south westwards for a distance of 5 metres
- k. Both sides of Lake Street Ferndale from the common boundary of No.s 76 and 77 south eastwards to the common boundary of No.s 78 and 79 a distance of 20 metres
- l. Both sides of Frederick Street Ferndale from its junction with Cross Lake Street south eastwards to Ferndale School Access Road a distance of 20 metres
- m. The north western side on Cross Lake Street Ferndale from the entrance to the Fire Station Access Road to its junction with Frederick Street a distance of 12 metres
- n. The eastern side of Gethin Road, Penygraig, from its junction with Penygraig Road northwards to a point opposite No 7 James Terrace
- o. The western side from of Gethin Road, Penygraig, from its junction with Penygraig Road northwards for a distance of 82 metres
- p. The northern side of the Unnamed Road adjacent to No 48 Partridge Road, Llwynypia from its junction with Partridge Road, Llwynypia, south eastwards for a distance of 38 metres
- q. The northern side of the Unnamed Road adjacent to No 48 Partridge Road, Llwynypia from its junction with Church Street north westwards for a distance of 4 metres


2. Cynon

- a. The western side of Rheola Street Penrhwciber from its junction with Cynon Terrace northwards for a distance of 10 metres
- b. Both sides of Cynon Terrace Penrhwciber from its junction with Rheola Street westwards for a distance of 5 metres

3. Taff

- a. The north eastern side of Windsor Place Ynysybwl from its junction with High Street north westwards to a point opposite the southern building line of No 2 Windsor Cottages a distance of 233 metres
- b. The south western side of Windsor Place Ynysybwl from its junction with High Street north westwards for a distance of 162 metres then from a point 187 metres from that junction north westwards for a distance of 42 metres
- c. The north side of Augustus Street Ynysybwl from its junction with Windsor Place westwards for a distance of 41 metres
- d. The south side of Augustus Street Ynysybwl from its junction with Windsor Place westwards for a distance of 29 metres
- e. The south eastern side of Cowbridge Road, Talbot Green, from a point 10 metres north east of its junction with Fanheulog south westwards to the entrance of the Council Depot a distance of 66 metres
