

1. Introduce waiting restrictions as described in Schedule 1



**Schedule 1 – Prohibition of Waiting At Any Time**

1. Both sides of Church Terrace, from its cul de sac end, northwards for a distance of 15 metres
2. Both sides of Glasfryn Terrace, from its junction with Church Terrace, north westward for a distance of 5 metres
