
**1. Tylacoch, Llanhari**

**Schedule 1 Prohibition of Waiting At Any Time**


**1. Tylacoch Llanharry**

- a. On the northern side of Tylacoch from a point opposite the common boundary of Nos. 45 and 46 Tylacoch north eastwards for a distance of 100 metres

**2. Ffordd Llanerch Llanharry**

- a. On both sides from its junction with Tylacoch northwards for a distance of 10 metres
