1. **Y ffordd ddi-enw rhwng Heol Newydd a Heol Abercynon**
 - a. Ochr y de, o'i chyffordd ogledol â Heol Abercynon hyd at ei chyffordd ddeheuol â Heol Abercynon, pellter o 106 o fetrau
 - b. O'r ffin ddwyreiniol wrth 120 Heol Abercynon, tuag at y de-ddwyrain, wedyn i gyfeiriad y gogledd-orllewin am 111 o fetrau, cyn mynd ymlaen o amgylch ochr fewnol y tro cam
 - c. Ochr y gogledd-ddwyrain, o Bont y Rheilffordd, i gyfeiriad y de-ddwyrain yn gyffredinol, am bellter o 74 o fetrau
 - d. Ochr y gogledd-ddwyrain, o'i chyffordd â Heol Abercynon i gyfeiriad y gogledd-orllewin, am bellter o 17 o fetrau
2. **Heol y Blanhigfa**
 - a. Ochr y gogledd-orllewin, o'i chyffordd â Ffordd Aberpennar, i gyfeiriad y de-orllewin am bellter o 32 o fetrau
 - b. Ochr y de, o'i chyffordd â Ffordd Aberpennar, i gyfeiriad y de-orllewin am bellter o 26 o fetrau
3. **Ffordd Aberpennar**
 - a. Ochr y dwyrain, o bwynt gyferbyn â ffin ddeheuol 81 Ffordd Aberpennar, i gyfeiriad y de-ddwyrain am bellter o 22 o fetrau
 - b. Ochr y gorllewin, o'i ffin ddeheuol â 81 Ffordd Aberpennar, i gyfeiriad y de-ddwyrain am bellter o 22 o fetrau
4. **Heol Aberdâr**
 - a. Ochr y de-ddwyrain, o ochr de-orllewin ei chyffordd â Stryd Nash, i gyfeiriad y de-orllewin am bellter o 40 o fetrau
 - b. Ochr y de-ddwyrain, o bwynt gyferbyn â ffin gyffredin 35/36 Heol Aberdâr i ochr dde-orllewin ei chyffordd â Stryd y Parc, am bellter o 19 o fetrau
5. **Stryd y Parc**
 - a. Ochr y gorllewin, o'r ffin ogledol â Rhif 42a, Stryd y Parc, hyd at ei chyffordd â Heol Aberdâr, am bellter o 13 o fetrau
6. **Llys Tŷ'r Twyn**
 - a. Ochr y dwyrain, o'i chyffordd â Heol Aberdâr, i gyfeiriad y de yn gyffredinol, am 13 o fetrau
 - b. Ochr y gorllewin, o'i chyffordd â Heol Aberdâr, i gyfeiriad y de yn gyffredinol, am 9.5 o fetrau

(REVOCATION AND WAITING RESTRICTIONS) ORDER 202*

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and of all other enabling powers, the effect of which will be to:

1. Revoke the Traffic Regulation Order specified in Schedule 1
2. Introduce waiting restrictions as described in Schedule 2
3. Introduce waiting restrictions between the hours of 8:30am to 6:30pm as described in Schedule 3

Schedule 1 – Revocation

1. The "Rhondda Cynon Taff County Borough Council (Aberdare Road Abercynon) (Waiting Restrictions) Order 2017" shall be revoked in its entirety

Schedule 2 – Prohibition of Waiting At Any Time

1. The Unnamed Road between New Road and Abercynon Road

- a. Southern side, from its northern junction with Abercynon Road to its southern junction with Abercynon Road, a distance of 106 metres
- b. From the eastern boundary of 120 Abercynon Road, in a general south-easterly, then north-westerly direction for a distance of 111 metres, proceeding around the inside of the hairpin bend
- c. North eastern side, from the Railway Bridge, in a general south-easterly direction for a distance of 74 metres
- d. North eastern side, from its junction with Abercynon Road, in a north-westerly direction for a distance of 17 metres

2. Plantation Road

- a. North western side, from its junction with Mountain Ash Road, in a south-westerly direction for a distance of 32 metres
- b. South eastern side, from its junction with Mountain Ash Road, in a south-westerly direction for a distance of 26 metres

3. Mountain Ash Road

- a. Eastern side, from a point opposite the southern boundary of 81 Mountain Ash Road, in a south-easterly direction for a distance of 22 metres
- b. Western side, from the southern boundary of 81 Mountain Ash Road, in a south-easterly direction for a distance of 22 metres

4. Aberdare Road

- a. South eastern side, from the south western side of its junction with Nash Street, in a south-westerly direction for a distance of 40 metres
- b. South eastern side, from a point opposite the common boundary of 35/36 Aberdare Road to the south western side of its junction with Park Street, a distance of 19 metres

5. Park Street

- a. Western side, from the northern boundary of No 42a Park Street, to its junction with Aberdare Road, a distance of 13 metres

6. Llys Ty'r Twyn

- a. Eastern side, from its junction with Aberdare Road, in a generally southerly direction for 13 metres
- b. Western Side, from its junction with Aberdare Road, in a generally southerly direction for 9.5 metres

Schedule 3 – Prohibition of Waiting between 8:30am – 6:30pm

1. Aberdare Road

- a. From the northern boundary of No. 43 Park Street, north eastwards for a distance of 5 metres
