Atodlen 2 – Gwahardd Aros ar Unrhyw Adeg

1. **Rhodfa Ilan, Rhydfelen**
 - a. **Ochr ogleddol** - o'i chyffordd â Heol Caerdydd i ochr de-orllewinol ei chyffordd â Chlos Heddfan, pellter o 60 metr.
 - b. **Ochr ogleddol** - o ochr ogledd-ddwyreiniol ei chyffordd â Chlos Heddfan, tua'r gogledd-ddwyrain am bellter o 48 metr.
 - c. **Ochr ddeheuol** - o'i chyffordd â Heol Caerdydd i ochr dde-orllewinol ei chyffordd â Gerddi Glan Taf, pellter o 40 metr.
 - d. **Ochr ddeheuol** - o ochr ogledd-ddwyreiniol ei chyffordd â Gerddi Glan Taf, tua'r gogledd-ddwyrain am bellter o 76 metr.
2. **Heol Caerdydd, Rhydfelen**
 - a. Ochr ddwyreiniol - o ochr ddeheuol ei chyffordd â Rhodfa Ilan, tua'r de-ddwyrain am bellter o 13 metr.

ORDER 2021**

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Order specified in Schedule 1
2. Introduce waiting restrictions as described in Schedule 2

Schedule 1 – Variation

1. The "Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2012" shall be varied by the removal of the following Order from the Schedule of Orders in its entirety:-
"Mid Glamorgan County Council (Unnamed Road from Cardiff Road (A4054) to Ilan Avenue, Rhydyfelin, Pontypridd) (Prohibition of Waiting) Order 1983"

Schedule 2 – Prohibition of Waiting At Any Time

1. **Ilan Avenue, Rhydyfelin**
 - a. **Northern side** – from its junction with Cardiff Road to the south western side of its junction with Clos Heddfan, a distance of 60 metres
 - b. **Northern side** – from the north eastern side of its junction with Clos Heddfan, north eastwards for a distance of 48 metres
 - c. **Southern side** – from its junction with Cardiff Road to the south western side of its junction with Gerddi Glan Taf, a distance of 40 metres
 - d. **Southern side** from the north eastern side of its junction with Gerddi Glan Taf, north eastwards for a distance of 76 metres
2. **Cardiff Road, Rhydyfelin**
 - a. Eastern side – from the southern side of its junction with Ilan Avenue, south eastwards for a distance of 13 metres
