ATODLEN 1 – Amrywio

1. Bydd "Gorchymyn Cydgrynhoi (Gwahardd a Chyfyngu ar Aros a Llwytho a Mannau Parcio ar Ochr y Ffordd) Cyngor Bwrdeistref Sirol Rhondda Cynon Taf 2012" yn cael ei amrywio drwy ddileu eitem 'ii' o Atodlen y gorchymyn y cyfeirir ato yn Atodlen y Gorchymyn fel "Gorchymyn (Heol Cross Inn, Heol Talbot a'r Heol Fawr, Llantrisant) (Dirymu, Amrywio a Gwahardd Aros ar unrhyw adeg) Cyngor Bwrdeistref Sirol Rhondda Cynon Taf 2010":

"Ochr dde-orllewinol Heol Cross Inn, o bwynt 98 metr i'r dde-dwyrain o ffin ddwyreiniol Rhif 20 Heol Cross Inn i gyfeiriad y dwyrain i'w chyffordd â'r Heol Fawr, am bellter o 292 metr"

ATODLEN 2 – Gwahardd aros ar unrhyw adeg

1. Dwy ochr y fynedfa i ddatblygiad preswyl Cwrt Tafarn, o'i chyffordd â Heol Cross Inn, i gyfeiriad y de am bellter o 5 metr.
2. Ochr dde-orllewinol Heol Cross Inn, Llantrisant o ochr orllewinol ei chyffordd â Chwrt Tafarn, i gyfeiriad y gogledd-orllewin am bellter o 10 metr
3. Ochr dde-orllewinol Heol Cross Inn, Llantrisant, o'i chyffordd â'r Heol Fawr i'r gogledd-orllewin i'w chyffordd â Chwrt Tafarn, am bellter o 332 metr.

(VARIATION AND WAITING RESTRICTIONS) ORDER 2021

AND (TRAFFIC CALMING MEASURES) NOTICE 2021

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Order specified in Schedule 1
2. Introduce waiting restrictions on the roads identified in Schedule 2

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose under Sections 90A, 90C and 90G of the Highways Act 1980, the Highways (Road Humps) Regulations 1999 and the Highways (Traffic Calming) Regulations 1999 and all enabling powers, to implement the following traffic calming measures:

3. Speed Cushions (minimum height 25mm, max height of 100mm, 1900mm wide), to be provided in pairs at, or within the vicinity of the locations specified in Schedule 3

SCHEDULE 1 – Variation

1. The "Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2012" shall be varied so that the order referred to in the Schedule of Orders as the "Rhondda Cynon Taff County Borough Council (Cross Inn Road, Talbot Road and Main Road, Llantrisant) (Revocation, Variation and Prohibition of Waiting At Any Time) Order 2010" shall be varied by the deletion of item 'ii' from its Schedule:

"The south western side of Cross Inn Road, from a point 98 metres southeast of the eastern boundary of No. 20 Cross Inn Road in an easterly direction to its junction with Main Road, a distance of 292 metres"

SCHEDULE 2 – Prohibition of Waiting At Any Time

1. Both sides of the entrance to Cwrt Tafarn residential development, from its junction with Cross Inn Road, southwards for a distance of 5 metres.
2. The south-western side of Cross Inn Road, Llantrisant from the western side of its junction with Cwrt Tafarn, north-westwards for a distance of 10 metres
3. The south-western side of Cross Inn Road, Llantrisant, from its junction with Main Road north westwards to its junction with Cwrt Tafarn, a distance of 332 metres.

SCHEDULE 3 – Speed Cushions

Speed Cushions (minimum height 25mm, max height of 100mm, 1900mm wide), to be provided in pairs at, or within the vicinity of the following locations:

Cross Inn Road, Llantrisant

1. 94 metres south east of the common boundary of No. 19 and 20 Cross Inn Road, Llantrisant
2. 27 metres south east of the common boundary of No. 19 and 20 Cross Inn Road, Llantrisant
