



Monday to Friday 8:00am – 9:00am and 3:00pm - 6:00pm

1. The south eastern side of the unnamed road between Ely Valley Road and Tylcha Fach Terrace from a point 12 metres north east of its junction with Ely Valley Road, north eastwards for a distance of 18 metres
