

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and of all other enabling powers, the effect of which will be to:

1. Introduce waiting, loading and unloading restrictions as described in Schedule 1
2. Introduce waiting restrictions between the hours of 8:00am to 6:00pm Monday to Friday as described in Schedule 2

Schedule 1 – Prohibition of Waiting, Loading and Unloading At Any Time

1. Club Street, Aberaman


- a. South side, from a point approximately 20 metres south west of its junction with Cardiff Road, in a south westerly direction for a distance of 49 metres
- b. South side, from a point approximately 10 metres north east of the junction with Blaengwawr Close, in a south westerly direction for a distance of 131 metres
- c. North side, from a point approximately 60 metres south west of the western boundary of No 1 Club Street in a south westerly direction for a distance of 56 metres

Schedule 2– Prohibition of Waiting between 8:00am – 6:00pm Monday to Friday

1. Club Street, Aberaman

- a. North side, from the common boundary of No. 3 and 4 Club street, in a south westerly direction for a distance of 24 metres
