

1. Introduce waiting restrictions as described in Schedule 1



**Schedule 1 – Prohibition of Waiting At Any Time**

1. The south eastern side of Bailey Street, from a point 12 metres south west of its junction with Miskin Road, south westwards to its junction with Glyngwyn Street
2. The north eastern side of Glyngwyn Street, from its junction with Bailey Street, south eastwards for a distance of 12 metres
