Dear Sir / Madam,

As you will be aware, during the construction of the Mountain Ash Cross Valley Link, waiting restrictions were temporarily introduced in Glyngwyn Street and Bailey Street to assist with traffic flow.

Following completion of these works, the council consulted residents on the temporary waiting restrictions and asked whether they would like the restrictions to remain or alternatively have them removed

The responses to the consultation showed that there was a desire from residents to remove the restrictions in Glyngwyn Street but that the restrictions in Bailey Street should remain.

Therefore arrangements will be made to remove the restrictions in Glyngwyn Street.

However, as the restrictions were introduced on a temporary basis, the council are required to give formal notice of the proposal to keep the restrictions in Bailey Street.

The next stage is a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any comments they may have. If you wish to comment on the proposals, you should do so in writing by 26 August 2021 to the Traffic Services Manager, Traffic Management, Sardis House, Sardis Road, Pontypridd, CF37 1DU or alternatively by email at trafficservices@rctcbc.gov.uk
