
Atodlen 1 – Amrywiad

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Order specified in Schedule 1
2. Introduce waiting restrictions as described in Schedule 2


Schedule 1 – Variation

1. The "Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2012" shall be varied in that the Order referred to in the Schedule of Orders as:-
"Mid Glamorgan County Council (Vaughan Terrace, Rheola Street and Unnamed Roads Leading to Glasbrook Street and the Penrhiwceiber Colliery, Penrhiwceiber) (Prohibition of Waiting) Order 1977" shall be varied by the deletion of item 'v' and 'vi' in their entirety

Schedule 2 – Prohibition of Waiting At Any Time

1. The western side of Rheola Street, Penrhiwceiber, from the southern side of its junction with Vaughan Terrace for a distance of 5.1 metres
2. The eastern side of Rheola Street, Penrhiwceiber, from the northern side of its junction with Vaughan Terrace for a distance of 13.8 metres
