

RHONDDA CYNON TAFF COUNTY BOROUGH COUNCIL

(CARDIFF STREET, ABERDARE)

(EXPERIMENTAL AMENDMENTS TO LOADING BAY

AND DESIGNATED HACKNEY CARRIAGE STAND) ORDER 2021

The Rhondda Cynon Taff County Borough Council ("the Council") in exercise of their powers under Sections 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order:

1. The Traffic Regulation Orders specified in the Schedule to this Order are hereby varied as described in the said Schedule for an experimental period of 18 months
2. The Rhondda Cynon Taff County Borough Council may provide for the suspension and modification of the order or part thereof, while it is in force if it appears that it is essential in the interest of the expeditious convenient and safe movement of traffic or else the provision of suitable and adequate parking facilities in the highway or for preserving or improving the amenities of the area through which any road affected by the order runs
3. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by any other enactment.
4. This Order shall come into operation on 28th June 2021 for an experimental period of 18 months and may be cited as the "Rhondda Cynon Taff County Borough Council (Cardiff Street, Aberdare) (Experimental Amendments to Loading Bay and Designated Hackney Carriage Stand) Order 2021".

SCHEDULE

Variations

1. The "Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2012" shall be varied so that the following orders referred to in the Schedule of Orders shall be varied as follows:
 - a. The Rhondda Cynon Taff County Borough Council (Cardiff Street, Aberdare) (Loading and Unloading Bays) Order 1997 shall be varied as follows:

Schedule 1 (i) shall now read:

On the north eastern side of Cardiff Street, Aberdare, from a point 3.7 metres south east of the common boundaries of Nos 2 and 3 Cardiff Street for a distance of 18.3 metres in a south easterly direction

- b. The Rhondda Cynon Taff County Borough Council (Cardiff Street, Aberdare) (Hackney Carriage Stand) Order 2008 shall be varied as follows:

Part (a) of the Schedule shall now read:

- a. Designated Hackney Carriage Stand, 9pm to 6am

The north eastern side of Cardiff Street, Aberdare, from a point 3.7 metres south east of the common boundary of No. 2 and No. 3 Cardiff Street, in a south easterly direction for a distance of 40.3 metres

c. The Rhondda Cynon Taff County Borough Council (Cardiff Street, Aberdare) (Variation) and (Prohibition of Waiting) Order 1997 shall be varied as follows:

Part 2 (a) of the Schedule shall now read:

Cardiff Street, Aberdare - North eastern side

a. From a point 3.7 metres south east of the common boundaries of Nos 2 and 3 Cardiff Street for a distance of 40.3 metres in a south easterly direction
