NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and of all other enabling powers, the effect of which will be to:

1. Introduce waiting restrictions as described in Schedule 1
2. Introduce loading and unloading restrictions between the hours of 7:00am to 7:00pm as described in Schedule 2

Schedule 1 – Prohibition of Waiting At Any Time

1. Llantrisant Road

- a. South eastern side, from the common boundary of The Oaks (Llantrisant Road) and No. 1 Y Deri, north eastwards for a distance of 53 metres

Schedule 2– Prohibition of Loading and Unloading between 7:00am – 7:00pm

1. Llantrisant Road

- a. South eastern side from the common boundary of The Oaks (Llantrisant Road) and No. 1 Y Deri, north eastwards for a distance of 53 metres

2. Y Deri

- a. Both sides of Y Deri, from its junction with Llantrisant Road, south eastwards for a distance of 14 metres
