

Atodlen 2 – Gwahardd Aros ar Unrhyw Adeg

1. Cornel ogledd-ddwyreiniol cyffordd Stryd Kingcraft / Stryd Conybeare; o ffin dde-ddwyreiniol Rhif 9 Stryd Kingcraft tua'r gorllewin ac yna i gyfeiriad y de ar hyd Stryd Conybeare am bellter o oddeutu 6 metr.
2. Cornel ogledd-ddwyreiniol cyffordd Stryd Kingcraft / Stryd Conybeare; o ffin dde-ddwyreiniol Rhif 10 Stryd Kingcraft, tua'r dwyrain a thua'r gogledd ar hyd Stryd Conybeare am bellter o oddeutu 11.2 metr.
3. Cornel dde-ddwyreiniol cyffordd Stryd Aberpennar / Stryd Conybeare; o ffin ogledd-orllewinol Rhif 17 Stryd Aberpennar Street tua'r gorllewin ac yna i'r de ar hyd Stryd Conybeare am bellter o 7.2 metr.
4. Cornel ogledd-ddwyreiniol cyffordd Stryd Aberpennar / Stryd Conybeare; o ffin dde-orllewinol Rhif 18 Stryd Aberpennar tua'r gorllewin ac yna i'r gogledd ar hyd Stryd Conybeare am bellter o 5.9 metr.
5. Och ddwyreiniol y gyffordd â Stryd Gorsedd / Stryd Conybeare / Stryd y Graig o bwynt 1.2 metr i'r dwyrain o ffin gyffredin Rhif 23 a Rhif 21 Stryd y Graig tua'r gorllewin ac yna tua'r de am bellter o 13.6 metr.
6. Cornel dde-orllewinol cyffordd Stryd Gorsedd a Stryd Conybeare o bwynt 2 fetr i'r gorllewin o ffin ddwyreiniol Rhif 1 Stryd Gorsedd tua'r de am bellter o 6.8 metr.

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Order specified in Schedule 1
2. Introduce waiting restrictions as described in Schedule 2


Schedule 1 – Variation

1. The “Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2012” shall be varied in that the Order referred to in the Schedule of Orders as:-
“Rhondda Cynon Taff County Borough Council (Various Roads, Darran Las, Mountain Ash) (Prohibition of Waiting At Any Time, One Way Traffic, No Stopping on ‘School Keep Clear’ Marking, 20MPH Speed Limit) Order 2008” shall be varied by the removal of the following items in their entirety from the Schedule Part 1 – Prohibition of Waiting At Any Time: -
 - a. Item (b)
 - b. Item (d)
 - c. Item (e)
 - d. Item (f)
 - e. Item (i)
 - f. Item (j)

Schedule 2 – Prohibition of Waiting At Any Time

1. The north eastern corner of the junction of Kingcraft Street / Conybeare Street; from the south western boundary of No. 9 Kingcraft Street, in a general west and then southwards direction along Conybeare Street for a distance of approximately 6 metres
2. The north eastern corner of the junction of Kingcraft Street / Conybeare Street; from the south eastern boundary of No. 10 Kingcraft Street, in a general east and northwards direction along Conybeare Street for a distance of approximately 11.2 metres
3. The south eastern corner of the junction of Aberpennar Street / Conybeare Street; from the north western boundary of No. 17 Aberpennar Street in a general west and then and the southwards direction along Conybeare Street for a distance of 7.2 metres
4. The north eastern corner of the junction of Aberpennar Street / Conybeare Street; from the south western boundary of No. 18 Aberpennar Street in a generally west and then northwards direction along Conybeare Street for a distance of 5.9 metres
5. The eastern side of the junction with of Gorsedd Street / Conybeare Street / Rock Street from a point 1.2 metres east of the common boundary of No. 23 and No. 21 Rock Street in a general west and then southwards direction for a distance of 13.6 metres
6. The south western corner of the junction of Gorsedd Street and Conybeare Street from a point 2 metres west of the eastern boundary of No. 1 Gorsedd Street southwards for a distance of 6.8 metres
