### **Cemetery Road, Taffs Well – Proposed Traffic Calming Features**

As part of Transport for Wales (TfW) plans to improve the South Wales Metro Core Valley Lines, proposals for a depot facility at the former Garth Works Industrial site have been approved by RCTCBC's Planning Committee. To accommodate the construction of the depot and the reconfiguration of Ffordd Bleddyn, TfW must divert the Taff Trail for up to eighteen months (NCN Route 8).

TfW's proposals will see the Taff Trail diverted onto Forest Road and Cemetery Road, with the route requiring a series of improvements such as the introduction of a cycle lane and traffic calming measures in order to safeguard vulnerable users.

Whilst the measures are primarily required to support the temporary diversion of the Taff Trail and will be removed upon completion of the Metro Depot, consideration would be given to retaining the cycle route and traffic calming on a permanent basis should the scheme have a positive impact on the wider community and there is support to do so. However, before such a decision can be made, the Council would seek to further consult with the Community on this matter.
