1. Stryd Rhydychen gyferbyn â Rhif 57 a 59, yr ochr orllewinol o'i chyffordd â'r Goedlan Fawr, i gyfeiriad y gogledd-ddwyrain a'r gogledd-orllewin am bellter o 14 metr
2. Stryd Rhydychen gyferbyn â Rhif 57 a 59, yr ochr ddwyreiniol o'i chyffordd â'r Goedlan Fawr i gyfeiriad y gogledd-orllewin am bellter o 10.5 metr
3. Ochr ogleddol Stryd Rhydychen, o ochr ddwyreiniol ei chyffordd â Rhed-yr-Helyg tua'r dwyrain i bwynt 1 metr i'r gorllewin o ffin gyffredin Rhif 47/49 Stryd Rhydychen. Peltir o tua 12 metr

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act"), after consultation with the Chief Officer of Police in accordance with Section 23(2)(a) of the said Act and having notified the Welsh Government in writing, proposes the following and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Order specified in Schedule 1
2. Introduce waiting restrictions on the roads identified in Schedule 2
3. Establish a Toucan Crossing at the location specified in Schedule 3

SCHEDULE 1 – Variation

1. The "Rhondda Cynon Taff County Borough (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2012" shall be varied so that the orders referred to as:
 - a. The "Rhondda Cynon Taff County Borough Council (Main Avenue and Oxford Street, Nantgarw) (Revocation, Restricted Roads and Prohibition of Waiting Order 2002" shall be varied by the removal of Item 2 of Schedule 3 in its entirety

SCHEDULE 2 – Prohibition of Waiting At Any Time

1. Oxford Street opposite No. 57 and 59, western side from its junction with Main Avenue, in a north easterly and a north westerly direction for a distance of 14 metres
2. Oxford Street opposite No. 57 and 59, eastern side from its junction with Main Avenue in a north westerly direction for a distance of 10.5 metres
3. The northern side of Oxford Street, from the eastern side of its junction with Rhyd-y-Helyg eastwards to a point 1 metre west of the common boundary of No. 47/49 Oxford Street. As distance of approximately 12 metres

SCHEDULE 3 – Toucan Crossing

1. To be established on Oxford Street, Nantgarw, near its junction with Rhyd Yr Helyg
