

**(TEMPORARY ROAD CLOSURE) ORDER 2021**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The closure is necessary to ensure public safety during the removal of a footbridge

The effect of the Order will be to close the A473 Bridgend Road, from a point 40 metres south of its junction with Chapel Road, southwards for a distance of 40 metres

**Alternative Route for Vehicles**

Available via A473 Bridgend Road, A473 New Road, Pen-y-Bont Road Roundabout, Brynna Road and Hillside Avenue


**Alternative Route for Pedestrians**

Available via Llanharan Railway Station Access Road, Llanharan Station Footbridge and Chapel Road

Access **WILL NOT** be maintained for pedestrians or emergency service vehicles

The closure is expected to be in operation from 10pm on 25th December to 10pm on 26th December 2021, or until such time as the works have been completed.
