DYMA HYSBYSIAD bod Cyngor Bwrdeistref Sirol Rhondda Cynon Taf yn bwriadu gwneud Gorchymyn, ar ôl o leiaf 7 diwrnod o ddyddiad yr Hysbysiad yma, o dan Adran 14 o Ddeddf Rheoleiddio Traffig Ffyrrd 1984, fel y'i diwygiwyd gan Ddeddf Traffig Ffyrrd (Cyfngiadau Dros Dro) 1991, a fydd yn para deunaw mis ar y mwyaf.

Mae angen cau'r ffordd yma er mwyn cynnal gwaith ar y ffordd neu yn ei hymyl sy'n gysylltiedig â dargyfeirio cyfleustodau.

Effaith y Gorchymyn fydd cau Heol Caerdydd, Glyn-taf, o ffin gyffredin Rhif 15 a Rhif 16 Heol Caerdydd, tua'r gogledd-orllewin am bellter o 30 metr.

Llwybr Amgen – Ar hyd ochr ddeheuol y ffordd sydd ar gau, ewch ar hyd yr A4054 Heol Caerdydd, cylchfan Glan-bad, yr A470 tua'r gogledd a Chyfnewidfa Glyn-taf i ochr ogleddol y ffordd sydd ar gau.

Fydd **DIM** mynediad ar gyfer cerbydau'r gwasanaethau brys.


Mae disgwyl i'r ffordd fod ar gau yn ystod y dyddiadau a'r amseroedd canlynol neu hyd nes y bydd y gwaith wedi'i gwblhau:

- Cau yn gyfan gwbl o 11:30pm ar 18 Chwefror hyd at 5:00am ar 28 Chwefror 2022 (Gwyliau Ysgol)
- Cau yn gyfan gwbl o 11:30pm ar 8 Ebrill hyd at 5:00am ar 24 Ebrill 2022 (Gwyliau Ysgol)

Mae'n bosib bydd yn rhaid cau'r ffordd am benwythnosau llawn o 11:30pm ar ddydd Gwener hyd at 5am ar ddydd Llun, yn ôl yr angen o 4 Mawrth hyd at 4 Ebrill 2022, neu hyd nes y bydd y gwaith wedi'i gwblhau.

(TEMPORARY ROAD CLOSURE) ORDER 2022

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The closure is necessary for works to be carried out on or near the road in connection with utility diversions.

The effect of the Order will be to close Cardiff Road, Glyntaf, from the common boundary of No. 15 and 16 Cardiff Road, north westwards for a distance of 30 metres

Alternative Route – via from the southern side of the closure, proceed via Cardiff Road A4054, Upper Boat Roundabout, A470 northbound and Glyntaff Interchange to the northern side of the closure.

From the northern side of the closure, proceed via Glyntaff Interchange, A470 southbound, Upper Boat Roundabout and Cardiff Road A4054 to the southern side of the closure

Access will be maintained for pedestrians

Access **WILL NOT** be maintained for emergency service vehicles

The closure is expected to be in operation from during the following dates and times, or until such time as the works have been completed:-

- Full Closure from 11:30pm on 18th February to 5:00am on 28th February 2022 (School Holidays)
- Full Closure from 11:30pm on 8th April to 5:00am on 24th April 2022 (School Holidays)

In addition, if necessary, full weekend closures from 11:30pm on Fridays to 5am on Mondays, as and when required from 4th March until 4th April 2022 or until the works are complete.

Advanced signage will be placed on site 7 days prior to each closure to inform the public when the closure will be in operation
