
- **9-24 Ebrill 2022 (gwyliau ysgol)**

(TEMPORARY TRAFFIC RESTRICTIONS) ORDER
2022

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The restriction is necessary for the installation of a new water main.

The effect of the Order will be to: -

1. Temporary Prohibition of Waiting At Any Time

River Street – western side from its junction with B4595 Fothergill Street to its junction with Castle Street

Duration – 22nd March – 8th April 2022

2. Temporary Road Closure

River Street, from No. 7 River Street to the junction of River Street and Castle Street

Duration

- **9th - 24th April 2022 (school holidays)**
- **Weekend closures from 8am on Saturdays to 8pm on Sundays, as required from 30th April – 22nd May 2022**
- **If necessary, a further full road closure will be needed in May 2022, depending on how works progress. Signage will be places on site 7 days prior to the closure in May to inform the public when the closure will be in operation**


Alternative Route – from the north side of the closure proceed via B4595 Fothergill Street, Broadway, A4054 Glyntaff Interchange, A470 southbound, Upper Boat Interchange, A473 Gwaelod-y-Garth Road, A473 Tonteg Road, A473 Tonteg Roundabout, B4595 Tonteg Road, B4595 Llantwit Road, B4595 Park Street to the southern side of the closure

Access to Forest Road will be available via Castle Street

NB: For the duration of the road closure, the "Mid Glamorgan County Council (Park Street, fothergill Street, Broadway, River Street, Forest road, Long Row and Castle Street, Trefforest) (Revocation and One Way Traffic) Order 1981" will be temporarily suspended (partially) to allow two way traffic in River Street, from its junction with Fothergill Street to No. 7 River Street to maintain access for residents vehicles.

Access for pedestrians and emergency service vehicles will be maintained at all times.
