- a. Yr ochr ogledd-ddwyreiniol, o bwynt 7 metr i'r de-ddwyrain o'i chyffordd de-ddwyreiniol â Stryd Taf, tua'r de-ddwyrain am bellter o 24 metr

- b. Yr ochr dde-ddwyreiniol, o bwynt 10 metr i'r gogledd-ddwyrain o'i chyffordd â Stryd Traws y Nant, i gyfeiriad cyffredinol y gogledd-ddwyrain am bellter o 29 metr



**(VARIATION, WAITING AND LOADING RESTRICTIONS, LOADING BAY, HACKNEY CARRIAGE STAND, DISABLED PARKING AND SPEED LIMIT) ORDER 2022 AND (TRAFFIC CALMING MEASURES) NOTICE 2022**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2, 4, 32, 35, 81, 82, 83 and 84 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Orders specified in Schedule 1
2. Introduce waiting restrictions as specified in Schedule 2
3. Introduce waiting, loading and unloading restrictions as specified in Schedule 3
4. Designate the lengths of road specified in Schedule 4 as Loading Bays
5. Designate the lengths of road specified in Schedule 5 as a Hackney Carriage Stand
6. Designate the lengths of roads specified in Schedule 6 as Disabled Persons Parking Places
7. Introduce a 20mph speed limit on the roads specified in Schedule 7

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council propose under Sections 90A, 90C and 90G of the Highways Act 1980, the Highways (Road Humps) Regulations 1999 and the Highways (Traffic Calming) Regulations 1999 and all enabling powers, to implement the following traffic calming measures:

8. Raised crossing (75mm high), to be provided at, or within the vicinity of the location specified in Schedule 8

**SCHEDULE 1 – Variations**

1. The "Rhondda Cynon Taff County Borough Council (Pontypridd Town Centre) (Revocation, Variation, Prohibition of Driving, Waiting and Loading Restrictions, Loading Bay and Disabled Parking Place Order) 2012" shall be varied as follows:
  - a. 'Part 3 – Prohibition of Waiting At Any Time' shall be varied by the removal of the following items:
    - i. Section 2 – Gas Road on both sides from its junction with Taff Street north east for its entire adopted length, a distance of approximately 40 metres
    - ii. Section 9 – item iv, v, vi, vii, viii
  - b. 'Part 3 – Prohibition of Waiting At Any Time' shall be varied in that 'Section 9 Taff Street – Item iii' shall now read:  
‘On its west side from a point 24 metres north of the southern boundary of No. 1 New Inn Centre to its southernmost junction with Crossbrook Street. A distance of approximately 315 metres’
  - c. 'Part 7 – Disabled Persons Parking Places' shall be removed in its entirety
  - d. 'Part 9 - Hackney Carriage Stand' shall be removed in its entirety
  - e. 'Part 10 – Monday to Saturday 8:00am – 6:00pm Loading Bay for Goods Vehicles Only, 6:00pm to 8:00am Any Day Hackney Carriage Stand' shall be removed in its entirety
  - f. 'Part 3 – Prohibition of Waiting At Any Time' shall now read 'Prohibition of Waiting and Loading At Any Time'
2. The "Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2012" shall be varied as follows:
  - a. The "Mid Glamorgan County Council (Taff Street (Part) and Library Road (Part) Pontypridd) (Prohibition of Waiting) (Variation) Order, 1976" shall be varied in the removal of Section 2 in its entirety
  - b. The "Mid Glamorgan County Borough Council (Pontypridd – Central Area) (Traffic Regulation) Order No.1 1979 shall be varied in that 'Crossbrook Street' shall be removed from Schedule 3 in its entirety
  - c. The "Mid Glamorgan County Borough Council (Pontypridd – Central Area) (Traffic Regulation) Order No.1 1979 shall be varied in that 'Mill Street (East)' shall be removed from Schedule 10 in its entirety

**SCHEDULE 2 – Prohibition of Waiting At Any Time**

1. **Taff Street**
  - a. north western side from a point 3 metres north east of its junction with Crossbrook Street, in a north easterly direction for a distance of 12 metres
2. **Crossbrook Street**
  - a. both sides from its junction with Gelliwastad Road and Morgan Street in a south easterly direction to a point 14 metres north west of its junction Taff Street

### **SCHEDULE 3 – Prohibition of Waiting, Loading and Unloading At Any Time**

- 1. Taff Street**
  - a. North western side, from its junction with Bridge Street, in a south westerly direction for a distance of 14 metres
  - b. South eastern side, from its junction with Bridge Street, in a south westerly direction for a distance of 27 metres
  - c. South eastern side, from its junction with Crossbrook Street, in a north easterly direction for a distance of 11 metres
  - d. South eastern side, from its southern most junction with Crossbrook Street in a general south westerly direction for a distance of 15 metres
- 2. Crossbrook Street**
  - a. North eastern side, from a point 14 metres north west of its north western junction with Taff Street, in a south easterly direction for a distance of 16 metres
  - b. North eastern side, from its north eastern junction with Taff Street, in a south westerly direction or a distance of 8 metres
  - c. North eastern side, from a point 31 metres south east of its north eastern junction with Taff Street, in a general south westerly direction for a distance of 21 metres
  - d. South western side, from a point 14 metres north west of its south western junction with Taff Street, in a south easterly direction for a distance of 41 metres
  - e. South western side, from a point 33 metres south east of its south eastern junction with Taff Street, in a south easterly and then a south westerly direction for a distance of 42 metres
  - f. The whole of the turning area situated at the south eastern end of Crossbrook Street, excluding the loading bay area
  - g. South eastern side, from the 'Gas Road' car park entrance in a north easterly direction for 20 metres

### **SCHEDULE 4 – Loading Bay At All Times**

- 1. Taff Street**
  - a. North western side, from a point 28.2 metres south west of its junction with Bridge Street, in a south westerly direction for a distance of 16.5 metres
  - b. North western side, from a point 69 metres south west of its junction with Bridge Street, in a south westerly direction for a distance of 10.6 metres
- 2. Crossbrook Street**
  - a. North eastern side, from a point 7 metres south east of its South eastern junction with Taff Street, in a south easterly direction for a distance of 24 metres
  - b. Situated in the turning area at the south eastern end of Crossbrook Street

### **SCHEDULE 5 – Hackney Carriage Stand At All Times**

- 1. Taff Street**
  - a. North western side, from a point 44.7 metres south west of its junction with Bridge Street, in a south westerly direction for a distance of 26.3 metres
  - b. South eastern side, from a point 10 metres north east of its junction with Crossbrook Street in a north easterly direction for a distance of 29 metres

### **SCHEDULE 6 – Disabled Persons Parking Places At All Times**

- 1. Taff Street**
  - a. North western side, from a point 79.6 metres south west of its junction with Bridge Street, in a south westerly direction for a distance of 15.6 metres

### **SCHEDULE 7 – 20MPH Speed Limit**


- 1. Taff Street**
  - a. from its south western junction with Crossbrook Street, north eastwards to its junction with Bridge Street for a distance of approximately 118 metres
- 2. Crossbrook Street in its entirety**

### **SCHEDULE 8 – Raised Crossing**

1. In the vicinity of No. 31 Taff Street
