Dear Sir/Madam,

As you might be aware, planning permission was granted for a new residential development adjacent to Llantrisant Road, Tonyrefail. In order to meet a planning condition, the local authority and developer have entered into an agreement to extend the existing 20mph zone with traffic calming features by approximately 595 metres in a northerly direction.

Further to the above, an uncontrolled pedestrian crossing point shall be situated on a flat-top road hump to ensure that pedestrians can access the newly-established footway from the residential development publicly known as Trem Y Dolau.

We seek to introduce these road safety measures to improve accessibility and reduce vehicle speeds at this location. Furthermore, it will ensure that motorists can negotiate the junction between Trem Y Dolau and Llantrisant Road in a safe manner. Details of the proposals are shown on drawing TM22/023/PN provided. Alternatively, you may wish to view them on the council's website: www.rctcbc.gov.uk/traffic.

The next stage in the process will be to give a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any comments they may have. If you wish to comment on the proposals, you should do so in writing by 07/12/22 to the Traffic Services Manager, Traffic Management, Sardis House, Sardis Road, Pontypridd, CF37 1DU or alternatively by email at trafficservices@rctcbc.gov.uk
