

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, the effect of which will be to:

1. Prohibit any vehicle, other than an exempted vehicle, exceeding the maximum gross weight limit of 7.5 tonnes from proceeding along the length of road specified in the Schedule


