NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council ("the Council") in exercise of its powers under Sections 1, 2, 4, 32, 35, 45 and 53 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, propose to make various orders the general effect of which will be: -

1. To Revoke the Traffic Regulation Orders specified Schedule 1 to this Notice.
2. To Vary the Traffic Regulation Orders as specified in Schedule 2 to this Notice
3. Designate the lengths of roads specified in Schedule 3 to this Notice, as Individual Permit Parking Places
