### (TEMPORARY ROAD CLOSURE) ORDER 2023

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The closure is necessary to carry out drainage works in connection with a new development

The effect of the Order will be to close Edward Street, from its junction with Margaret Street, south westwards for a distance of 55 metres

**NB** the closure will extend across the junction of Herbert Street

#### **Alternative route**

From the southern side of the closure, proceed via Herbert Street, Walter Street and Margaret Street.  
From the northern side of the closure, proceed via Edward Street / Mountain Ash Road, Ynysmeurig Road, Station Road and Herbert Street

Access will be maintained for pedestrians

Access **WILL NOT** be maintained for emergency service vehicles

Access to premises will be maintained

The closure is expected to be in operation between the following dates, or until such time as the works has been completed:-

- Full Closure from 9th October to 10th November 2023**

**NB Please note that access will be maintained for School Buses Monday to Friday from 7:45am – 8:30am and from 2:50pm to 3:40pm each day**
