Mae angen cau'r ffordd er mwyn cynnal gwaith ar y ffordd neu yn ei hymyl i adeiladu cilfan bws oddi ar Heol Sardis

Effaith y Gorchymyn fydd cau rhan o'r llwybr troed ar Heol Sardis, o bwynt sydd 6 metr i'r de ddwyrain o Rif. 17 Heol Sardis, i gyfeiriad y dwyrain am bellter o 67 metr.

Llwybr amgen i gerddwyr - ar gael o gyffordd Heol Sardis â'r Stryd Fawr, gan ddefnyddio'r groesfan i gerddwyr, ewch ar hyd ochr de-orllewinol Heol Sardis gan ddilyn y llwybr troed i gyfeiriad y gogledd a defnyddio'r groesfan i gerddwyr er mwyn cyrraedd ochr ogleddol y llwybr troed sydd wedi cau.



(TEMPORARY FOOTWAY CLOSURE) ORDER 2023

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The closure is necessary for works to be carried on or near the road to construct a bus layby off Sardis Road.

The effect of the Order will be to close the section of footway on Sardis Road, from a point 6 metres southeast of No. 17 Sardis Road, south eastwards for a distance of 67 metres

Alternative route for pedestrians - is available from the junction of Sardis Road and High Street, using the pedestrian crossing, proceed to the south western side of Sardis Road, following the footway northwards and use the pedestrian crossing to reach the northern side of the footway closure.


Access will be maintained for emergency service vehicles

Access to premises will be maintained

The closure is expected to be in operation between the following dates, or until such time as the works has been completed:-

- **Full closure from 2nd October to 30th November 2023 and**
- **Full closure from 2nd January 2024 to 1st August 2024**
