- **Stryd y Felin**, rhwng Rhif 1 a Rhif 11a Stryd y Felin
- **Y Stryd Fawr** - ar ei hyd
- **Stryd y Farchnad**, o'i chyffordd â Stryd yr Eglwys i'w chyffordd ddeheuol â Stryd Taf.

Llwybr Amgen - o ochr ogledol y ffordd sy'n cau, ewch ar hyd Stryd Traws y Nant, Heol Gelliwastad, Stryd Catrin, a Heol Sardis tuag at ochr ddeheuol y rhan o'r ffordd sydd wedi'i chau.

DS: Bydd mynediad ar gael yn unig i adeiladau hyd at gyffordd ogledol Stryd Taf â Stryd y Farchnad. Bydd modd i yrwyr deithio ar hyd Stryd y Farchnad a Stryd yr Eglwys i ochr ddeheuol y rhan sydd wedi'i chau.

(TEMPORARY ROAD CLOSURE) ORDER 2023

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The closure is necessary to facilitate a drainage connection needed for the Sardis Road Bus Layby Scheme

The effect of the Order will be to close the following roads: -

- **Taff Street**, from its northern junction with Market Street to its junction with High Street
- **Mill Street**, between No. 1 and 11a Mill Street
- **High Street**, entire length
- **Market Street**, from its junction with Church Street to its southern junction with Taff Street

Alternative route - available from the northern side of the closure, proceed via Crossbrook Street, Gelliwastad Road, Catherine Street and Sardis Road to the southern side of the closure.

NB: Access only will be allowed to premises as far as the northern junction of Taff Street with Market Street. Vehicles will be able to proceed via Market Street and Church Street to the southern side of the closure.


Access will be maintained for pedestrians and emergency service vehicles

The closure is expected to be in operation between the following dates and times, or until such time as the works has been completed:-

- **Sunday only closures between 8:00am – 6:00pm on 19th and 26th November 2023**
