

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2, and 4 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, the effect of which will be to:

1. Introduce waiting restrictions as specified in Schedule 1



SCHEDULE 1 – Prohibition of Waiting At Any Time

Cemetery Road, Treorchy

1. Western side, from a point 10 metres north of its junction with Bute Street to a point 39 metres north of its junction with Bute Street for a distance of approximately 29 metres
2. Eastern side, from a point 10 metres north of its junction with Bute Street to a point 19 metres north of its junction with Bute Street for a distance of approximately 9 metres
