**Clydach Vale, Various Streets – Alterations to Double Yellow Lines.**

As you may be aware, the council has consulted on proposals to make changes to parking restrictions in Clydach Vale. The Council proposes to amend double yellow lines at several locations throughout Clydach Vale. This will include the reduction of double yellow lines outside No.35 Court Street for extra on street parking at this location.

The next stage in the process will be to give a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any comments they may have.
