

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2, 4, 32, 35, 45, 53 and 124 of the Road Traffic Regulation Act 1984 (“the Act”), and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Orders specified in Schedule 1
2. Introduce Waiting Restrictions as specified in Schedule 2
3. Introduce Loading and Unloading restrictions as specified in Schedule 3
4. Introduce Limited Waiting restrictions as specified in Schedule 4 and 6
5. Designate the lengths of road specified in Schedule 5 as Goods Vehicle Loading Bays
6. Designate the lengths of road specified in Schedule 7 as Disabled Persons Parking Places
7. Designate the lengths of roads specified in Schedule 8 as Hackney Carriage Stand
8. Introduce a one way traffic system as specified in Schedule 9
9. Introduce Prohibition of Pedestrians as specified in Schedule 10
10. Introduce Prohibition of Entry except for Buses as specified in Schedule 11
11. Introduce Prohibition of Entry as specified in Schedule 12
12. Introduce No Entry Except for Access as specified in Schedule 13

SCHEDULE 1 – Variations

1. The “Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2012” shall be varied so that the following Orders from the Schedule of Orders are removed in their entirety:-
 - a. The “Rhondda Cynon Taff County Borough Council (Station Street, Porth) (Revocation, Prohibition of Waiting, Loading and Unloading At Any Time, Prohibition of Waiting At Any Time, Designated Loading Bay and Designated Taxi Rank) Order 2005”
 - b. The “Mid Glamorgan County Council (Powells Place and Access Area, Porth) (Prohibition of Waiting) Order 1978”
 - c. The “Rhondda Cynon Taff County Borough Council (West Taff Street and Station Street, Porth) (Prohibition of Waiting At Any time, Prohibition of Loading and Unloading at Any Time and Limitation of Waiting) Order 2007”
2. The “Rhondda Cynon Taff County Borough Council (Various Streets in Rhondda Cynon Taff) Review of Existing Traffic Regulation Orders 2012” shall be varied by the removal of the following item in its entirety
 1. Schedule 1, Rhondda, Part 3 Prohibition of Waiting At Any Time
“47. Station Street, Porth

The north west side of Station Street from its junction with Pontypridd Road to its junction with West Taff Street a distance of 93 metres and the south east side of Station Street from a point 4 metres south west of its junction with Hannah Street south westwards for a distance of 15 metres”

SCHEDULE 2 – Prohibition of Waiting At Any Time

1. The northern side of Station Street from its junction with Pontypridd Road, north eastwards for a distance of 10 metres
2. The northern side of Station Street from a point 37 metres north east of its junction with Pontypridd Road, north eastwards for a distance of 44 metres
3. The southern side of Station Street, from its junction with Pontypridd Road, north eastwards for a distance of 91 metres
4. The south western side of West Taff Street from the south eastern side of No1 West Taff Street, north westwards for a distance of 222 metres
5. The north eastern side of West Taff Street, from a point opposite the common boundary of No’s 5 and 6 West Taff Street, north westwards for a distance of 28 metres
6. The north eastern side of West Taff Street, from a point 4 metres north west of a point opposite the common boundary of No’s 16 and 17 West Taff Street, north westwards for a distance of 126 metres
7. The south western side of Station Street, (fronting the north east wall of the Washington Buildings and the church), from a point opposite the north east flank wall of the Washington Buildings to a point opposite the north western flank wall of no. 38 West Taff Street, a distance of approximately 29 metres
8. The whole circumference of the island on the south east side of Station Street, located opposite the Washington Buildings
9. North Eastern side of the unnamed access road leading to the rear of nos. 1– 38 West Staff Street from a point opposite the north west flank wall of No 38 West Taff Street, for a distance of 2.5 metres in a north westerly direction
10. South Eastern side of Station Street, (adjacent to no. 38 West Taff Street), from a point 3 metres north of the northern corner of no 38 West Taff Street for a distance of 6.5 metres in a generally South Westerly direction
11. The eastern side of Porth Transport Hub exit road, from its junction with Station Road, northwards for a distance of 22 metres
12. The western side of Porth Transport Hub exit road, from its junction with Station Street, northwards for a distance of 11 metres
13. Both sides of the access road to Powells Place between its junction with the entrance road to Porth Transport Hub for its entire length including its cul de sac end
14. The northern side of the entrance to Porth Transport Hub from its junction with Pontypridd Road, south eastwards for a distance of 47 metres

15. The southern side of the access road to Porth Transport Hub from its junction with Pontypridd Road eastwards for a distance of 20 metres

SCHEDULE 3 – Prohibition of Loading and Unloading At Any Time

1. The southern side of the access road to Porth Transport Hub from its junction with Pontypridd Road eastwards for a distance of 20 metres
2. The northern side of the entrance to Porth Transport Hub from its junction with Pontypridd Road, south eastwards for a distance of 47 metres
3. The southern side of Station Street, from its junction with Pontypridd Road eastwards to its junction with Hannah Street
4. The northern side of Station Street from its junction with Pontypridd Road, eastwards for a distance of 10 metres
5. The northern side of Station Street from a point 37 metres east of its junction with Pontypridd Road, eastwards for a distance of 19 metres
6. The south western side of Station Street, (fronting the north east wall of the Washington Buildings and the church), from a point opposite the north east flank wall of the Washington Buildings to a point opposite the north western flank wall of no. 38 West Taff Street, a distance of approximately 29 metres
7. The whole circumference of the island on the south east side of Station Street, located opposite the Washington Buildings
8. North Eastern side of the unnamed access road leading to the rear of nos. 1– 38 West Staff Street from a point opposite the north west flank wall of No 38 West Taff Street, for a distance of 2.5 metres in a north westerly direction

SCHEDULE 7 – Disabled Persons Parking Place

1. The north eastern end of Station Street, (fronting the railway station) from a point 148 metres north west of a point opposite the common boundary of 16/17 West Taff Street north westwards for a distance of 5 metres (1 no. bay)

SCHEDULE 8 – Hackney Carriage Stand

1. The northern side of Station Street, from a point 81 metres north east of its junction with Pontypridd Road, north eastwards for a distance of 20 metres

SCHEDULE 9 – One Way Traffic

No person shall cause or permit any vehicle to proceed in the lengths of road specified in Column 1, in a direction other than that specified in Column 2

Station Street between the western side of its junction with Hannah Street and its junction with Pontypridd Road.	South Westerly

SCHEDULE 10 – Prohibition of Pedestrians

1. No pedestrian shall proceed within the extents of the Porth Transport Hub between its entrance 45 metres south east of south east of Pontypridd Road and a point 8 metres north west of its exit at its junction with Station Street

SCHEDULE 11 – Prohibition of Entry Except for Buses

1. No person shall cause or permit any vehicle except for buses to proceed within the extents of the Porth Transport Hub between its entrance 45 metres south east of Pontypridd Road and its exit at its junction with Station Street


SCHEDULE 12 – Prohibition of Entry

1. No person shall cause or permit any vehicle to enter the Porth Transport Hub at its junction with Station Road

SCHEDULE 13 – No Entry Except for Access

1. No person shall cause or permit any vehicle to proceed within the road leading to the Porth Transport Hub from a point 21 metres south east of its junction with Pontypridd Road except for access
