

(TEMPORARY ROAD CLOSURE) ORDER 2023

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The closure is necessary to facilitate carriageway resurfacing

The effect of the Order will be to close Park Street, from its junction with Castle Street to the northern boundary of No. 66 Park Street

NB the "Mid Glamorgan County Council (Park Street, Fothergill Street, Broadway, River Street, Forest Road, Long Row and Castle Street, Trefforest) (Revocation and One Way Order Traffic) Order 1981" will be temporarily suspended where it refers to the section of Park Street from the northern boundary of No 66 Park Street to a point 15 metres south-east of its junction with Fothergill Street – to allow vehicular access to Nos 1-4 River Street

Alternative route is available via Castle Street, Forest Road, Park Street, Llantwit Road, Tonteg Road, Upper Boat Roundabout, A470, Glyntaf Interchange and Fothergill Street


Access will be maintained for pedestrians and emergency service vehicles

Access to premises will be maintained

The closure is expected to be in operation between the following dates and times, or until such time as the works has been completed:-

- **Daytime closure from 9:00am – 4:00pm on Sunday 11th and 18th June 2023**
