

**(TEMPORARY ROAD CLOSURE) ORDER 2024**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The closure is necessary to facilitate carriageway resurfacing.

The effect of the Order will be to close High Street, Llantrisant, from its junction with the B4595 in a generally north westerly direction for a distance of approximately 110 metres.


**Alternative Route** – available via Heol-y-Sarn, Ely Valley Road and the B4595
