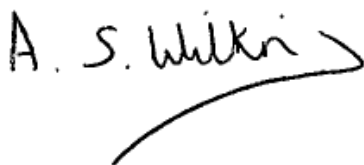
Cau Ffordd Dros Dro

1. **Ffordd Pen-y-wal**, o'i chyffordd â Ffordd Graigwen, tua'r gogledd-orllewin i'w chyffordd â Theras y Graig - pellter o 2.55 cilometr
2. **Ffordd Graigwen**, o'i chyffordd â Ffordd Pen-y-Wal, tua'r de-ddwyrain am bellter o 65 metr.

(TEMPORARY ROAD CLOSURE) NOTICE 2025

NOTICE IS GIVEN by Rhondda Cynon Taff County Borough Council ("the Council") that in accordance with its powers under Section 14(2) of the Road Traffic Regulation Act 1984 (as amended) the following length of road shall be closed for a maximum period of 21 days.

The closure is necessary to facilitate emergency repairs to a collapsed section of road.

The closure will be in operation **between 7th – 27th November 2025**, or until such time as the works has been completed.

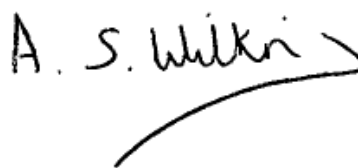
Temporary Road Closure

1. **Pen-y-Wal Road**, from its junction with Graigwen Road, north-westwards to its junction with Rock Terrace - a distance of 2.55 kilometres
2. **Graigwen Road**, from its junction with Pen-y-Wal Road, south-eastwards for a distance of 65 metres

Alternative route - available via Rock Terrace, Clydach Road, Windsor Place, Robert Street, New Road, B4273 Ynysybwl Road, Berw Road, Morgan Street, Gelliwastad Road, Gelliwastad Grove, Thomas Street, Graigwen Place and Graigwen Road.

Access will be maintained for emergency services, pedestrians and to premises.
