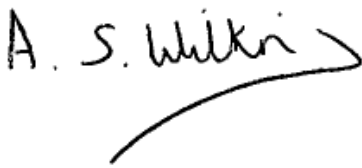

(TEMPORARY ROAD CLOSURE) NOTICE 2026

NOTICE IS GIVEN by Rhondda Cynon Taff County Borough Council ("the Council") that in accordance with its powers under Section 14(2) of the Road Traffic Regulation Act 1984 (as amended) the following length of road shall be closed for a maximum period of 21 days.

The closure is necessary to facilitate emergency repairs to a gas leak.

The closure will be in operation **from 8th to 15th January 2026**, or until such time as the work has been completed.

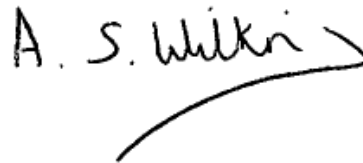
Temporary Road Closure

Cornwall Road, from the southern side of its junction with Brook Street to its junction with the Williamstown Roundabout, a distance of 50 metres.

Alternative Route – available via A4119, Station Street, Hendrecafn Road, Tylacelyn Road, Penygraig Road and Brook Street

Access will be maintained for emergency services, pedestrians or to premises.
