Effaith y Gorchymyn fydd cau'r rhannau canlynol o'r ffordd:-

1. **Ffordd Graigwen**, o'i chyffordd â Chlos Llanwynno, tua'r gogledd-orllewin i'w chyffordd â Ffordd Pen-y-wal (grid gwartheg).
2. **Ffordd Pen-y-wal**, o'i chyffordd â Ffordd Graigwen, tua'r gogledd-orllewin i'w chyffordd â Theras y Graig - pellter o 2.55 cilometr

Llwybr Amgen - ewch ar hyd Teras y Graig, Heol Clydach, Maes Windsor, Stryd Robert, Heol Newydd, Heol Ynysybwl B4273, Heol Berw, Stryd Morgan, Heol Gelliwastad, Llwyn Gelliwastad, Stryd Thomas, Maes Graigwen a Ffordd Graigwen.



(TEMPORARY ROAD CLOSURE) ORDER 2024

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The closure is necessary to facilitate works to widen the road to accommodate an abnormal load delivery.

The effect of the Order will be to close the following lengths of roads: -

1. **Graigwen Road**, from its junction with Llanwonno Close, north-westwards to its junction with Pen-y-Wal Road (the cattle grid)
2. **Pen-y-Wal Road**, from its junction with Graigwen Road, north-westwards to its junction with Rock Terrace - a distance of 2.55 kilometres

Alternative route - available via Rock Terrace, Clydach Road, Windsor Place, Robert Street, New Road, B4273 Ynysybwl Road, Berw Road, Morgan Street, Gelliwastad Road, Gelliwastad Grove, Thomas Street, Graigwen Place and Graigwen Road.


Access will be maintained for pedestrians and emergency services.
