

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council in exercise of their powers under Section 23 of the Road Traffic Regulation Act 1984 and after consultation with the Chief Officer of Police in accordance with Section 23(2)(a) of the said Act and having notified the Welsh Government in writing, proposes the following:

1. Establish a Puffin Pedestrian Crossing on the B4275 Aberaman, at a point 44 metres south east of the centre of its junction with the Aberaman Park Industrial Estate
